HOW FAR WE'VE COME: FREE THE OCKLAWAHA

For years, we have worked to raise awareness about the aging Rodman/Kirkpatrick Dam, and the benefits of breaching it to reunite Silver Springs, the Ocklawaha and the St. Johns. Recent public surveys and polls have confirmed overwhelming support for restoration.

In September/October 2021, the St. Johns River Water Management District (SJRWMD) conducted an online survey to collect feedback regarding the Kirkpatrick Dam and Rodman Reservoir. **Over 86.5% of the participants expressed a desire to restore a free-flowing Ocklawaha River. Only 5.9% of responses were in favor of retaining the dam and reservoir.**

Then in February of this year, highly regarded public opinion researcher Barcelo & Company released a scientific poll of likely voters in Putnam and Marion counties regarding the dam and restoration. **They found that nearly 80% of likely voters in these two counties favor breaching the dam and restoring the natural flow of the Ocklawaha. Only 6% were opposed to restoration.** Additional polling focusing exclusively on residents of Putnam County found **nearly 75% of**

likely voters in the county support breaching the dam, with only 7% in opposition.

A new economic briefing released February 15 by Florida TaxWatch “supports the breaching of the Kirkpatrick Dam and the partial restoration of the natural flow of the Ocklawaha River,” as this solution was found to be **in Florida taxpayers’ best interest.**

A recently released dam assessment report reclassifies the dam **from low hazard to high hazard**, meaning a failure could result in the loss of life and significant economic losses. This provides one more important reason to urgently move forward with restoration.

While we are disappointed the Florida Legislature failed to take action during the recent legislative session, our collective efforts continue to build significant momentum towards a free-flowing Ocklawaha. Overwhelming support and commitment from people up and down The Great Florida Riverway have brought us closer to restoration than ever before. MIDDLE BASIN UPDATE

St. Johns RIVERKEEPER works to protect all 310 miles of the St. Johns River, including the Middle Basin section, which stretches from the Econlockhatchee River to the Ocklawaha River.

SEMINOLE AND VOLUSIA 2070

In late 2021, we held two 2070 growth management workshops in partnership with 1000 Friends of Florida to develop a coalition of advocates for sustainable development in Volusia and Seminole Counties. The *Florida 2070* project reveals that if we continue with the status quo, more than a third of Florida's lands will be developed and development-related water demand will more than double by 2070. On the other hand, if we promote more compact development patterns and increase protected natural lands, we will save 1.8 million acres of natural and agricultural land.

WETLAND DEVELOPMENT THWARTED

Unity Resorts, LLC recently planned to build a Tree House Resort on wetlands along Shell Creek in Lake County, FL. Your St. Johns Riverkeeper wrote a letter of objection, and our Middle Basin Coordinator went to the planning and zoning meeting to voice concerns and oppose negative impacts to our river's wetlands. The application was withdrawn thanks to opposition from St. Johns Riverkeeper and the community.

REMEMBERING BILL BELLEVILLE

Bill Belleville was a renowned environmental writer and filmmaker and a true friend of our river and St. Johns Riverkeeper. In partnership with Friends of the Wekiva River, we recently organized the First Annual Bill Belleville Memorial Paddle on the Wekiva River. More than 20 paddlers came together and enjoyed this stretch of the watershed that Bill loved so much. Learn more about Bill and the St. Johns by reading his acclaimed book, "River of Lakes."

ARE YOU RIVER-FRIENDLY?

The choices we make in our own backyards now will affect our river well into algae bloom season. Warmer waters and increasingly polluted stormwater from intense weather create perfect conditions for the rapid growth of blue-green algae, or cyanobacteria.

Nutrient pollution that fuels these blooms comes from a variety of sources, including industrial and municipal wastewater, fertilizers, manure, and sewage sludge.

What you can do:

- Properly maintain septic tanks and **minimize your use of fertilizers**, especially when storms are expected. If you do use fertilizer, apply the proper amount and use a slow-release, organic product to reduce the likelihood of runoff.
- Keep leaves and grass clippings **out of storm drains**.
- Create beds using **native or low-maintenance plants** next to water bodies, streets, driveways, and sidewalks.
- **Contact your elected officials** and voice support for funding to remove failing septic tanks, prevent flooding and implement green infrastructure to capture and treat stormwater.
- Visit the Florida Algae Bloom Dashboard to check water quality status and report blooms: floridadep.gov/algalbloom. Also, report blooms to us at report@sjrk.org.
- **Get Your Feet Wet** in your river-friendly efforts: participate in one of our cleanups! Rising Tides, our young professionals group, hosts one each month on McCoys Creek.
